



TRAVEL REGULATIONS

RULES OF THE ORGANIZATION WELTSICHT

1. Contact / Registration

The first contact and registration is non-binding. Once you have decided to definitely book the trip, you will receive a confirmation via email with binding registration and advance payment

2. Payment / Finances

The guests / tour participants are responsible to pay in advance for the full trip /action of their choice, presumably without the flight. The flight is ideally booked independently. That's why we can offer the trips so cheap

If someone wishes this, your flight can still be booked separately for you via Team Weltsicht at an additional charge of CHF 250

Carrying out the trips has top priority, but also includes the rules regarding the number of participants in the case of a group trip. If the trip does not take place, the money will be refunded in full. Which is very rarely the case. This will be announced well in advance and alternative solutions will be offered so that you can still enjoy the country's culture with a similar program. This is of course excluded for individual tours

ATTENTION – VISA + ENTRY DOCUMENTS + SPECIAL PERMITS are the responsibility of the travelers themselves. Please clarify early!
(Local Ambassadors)

ON OUR SIDE :

Permit: The organizer / tour guide organizes all necessary permits, if necessary (free camping, entrance fees, etc.)

Helpers: The helpers are organized by the tour guide and hired by the Weltsicht team

3. Rules

If one or more group rules are not adhered to, also with appropriate appearance on site a consequence follows. If rules are broken, like getting drunk with alcohol, drug consumption or aggressive or offensive behavior by one party is to be expected with an immediate travel reprimand without return of the travel sum. In the case of a dispute, the place of jurisdiction is Switzerland

4. Changes

Changes to a travel agreement require approval from the organizer and must be submitted and confirmed in writing in advance. Handwritten changes and independent entries in contract copies or via email are not permitted. Every travel registration is therefore archived

5. Cancellation

You can cancel a trip at any time, but without reimbursement of the travel costs. After paying for the trip, the financial part becomes binding. The journey can in the event of illness or accident, etc. only be repeated on the next trip, or the value with another trip be agreed

6. Meals / Accommodation

Is organized and provided by the tour guide helper in the team served on site. Mainly vegetarian or vegan on request. Shopping, Cooking, drinks – stationary or during Travel is usually served by the team

7. Liability / Insurance

The organizer is not liable for theft, that happens during the tour. As well physical accidents, or material damage, the tour guide / group and guests themselves must be insured for international travel

8. Visa

The customer is responsible for any visa responsible for obtaining this from the consulate

The above guidelines from the travel organization become legally binding upon confirmation of registration and advance payment, in accordance with the guidelines of the Weltsicht CH organization. Each tour guide works as a self-employed person and only offers their services via Weltsicht CH. Any surpluses from the project income will be used as a donation for our association's purpose or the provider's commission will be donated directly to a purpose-oriented project
